All charged amounts (including confirmation fee & optional deposits) are final sale and non-refundable.

A \$1,000 non-refundable Confirmation Fee is due upon signing the order sheet.

NO Changes can be made to the order sheet after customer has signed the order sheet and paid the confirmation fee.

All prices are subject to change without notice prior to the signing of the build sheet and receipt of nonrefundable deposit from purchaser. OGTLP/OGTUS Corp reserves the right to change pricing due to market fluctuations.

Cancellation of purchase will entitle Off Grid Trailers LP / Off Grid Trailers US Corp. to a cancellation fee of 5% of the pretax contract price, payable within 30 days of cancellation.

Shipping charges are to be the responsibility of the purchaser AND are estimated costs ONLY. Final costs for shipping will be included on the final invoice.

OGT will invoice 4 weeks prior to production completion for full invoice payment, less the \$1,000 confirmation fee. Any changes to legal name and address, if not advised upon signing final order sheet, are be subject to a \$150 administrative fee.

Final payment options, subject to change, include wire transfer/certified bank draft/cashiers cheque.

Note that delivery/completion estimates are estimates only and are subject to change.

Should the quoted estimated trailer completion date be in excess of 6+ months, then the contract is subjected to a price variance of up to \$2000.
